**ELIGIBILITY & MEDIA**

ORIGINAL WORK ONLY, COMPLETED WITHOUT SUPERVISION. WORKS THAT HAVE BEEN PREVIOUSLY SUBMITTED TO THE TIPTON COUNTY ART EXHIBIT ARE INELIGIBLE. **MEDIA:** ACRYLIC, WATERCOLOR, COLLAGE, MIXED MEDIA, OIL, PASTEL & OTHER DRY MEDIA. WORKS MUST BE APPROPRIATELY FRAMED, WITH ATTACHED WIRE FOR HANGING. WEIGHT LIMIT, 40 LBS. SIZE LIMIT, MINIMUM IMAGE SIZE – 11 x 14 (OR 154 SQ. INCHES) MAXIMUM IMAGE SIZE 20 X 30 INCHES. MINIMUM FRAMED SIZE 14 X 17, MAXIMUM FRAMED SIZE 24 X 34 INCHES. PLEXIGLASS IS REQUIRED FOR ALL ARTWORK EXCEPT ACRYLIC, OIL & FRENCH PASTEL.

## ART LOAN AGREEMENT

**SCOPE OF SERVICES:** Lenders agree to loan their work (listing attached) to the Exhibitor for display at the following location(s); check all that apply:

**DELIVERY AND REMOVAL:** Lenders are responsible for removing the work within 5 days following the end of the Agreement.

**INSURANCE:** Objects accepted as loaned property by the College shall be insured by the College only when the College is provided with an Artwork Inventory List with the value of the Object included (Attachment 1). If no insurance value is provided by the Lender, it is agreed that the College shall not be responsible for any damage or loss to the Object. For loaned objects valued at \$50,000 or more, a written appraisal and photograph are required (an appraisal by a qualified State Curator is acceptable). Dyersburg State Community College will notify Lenders promptly if it becomes aware of damage, destruction, or theft of the artwork.

**TERMINATION FOR CONVENIENCE:** Either party may terminate this Agreement without cause by giving at least ten (10) days written notice.

**NONDISCRIMINATION:** The parties agree to comply with Titles VI and VII of the Civil Rights Act of 1964, Title IX of the Education Amendments of 1972, Section 504 of the Rehabilitation Act of 1973, Executive Order 11,246, the Americans with Disabilities Act of 1990 and the related regulations to each. Each party assures that it will not discriminate against any individual including, but not limited to, employees or applicants for employment and/or students because of race, religion, creed, color, sex, age, disability, veteran status or national origin.

**REQUIRED APPROVALS:** The Exhibitor is not bound by this Agreement until it is approved by the appropriate officials in accordance with applicable Tennessee state laws and regulations.

**AGREEMENT MODIFICATION:** This Agreement may be modified only by a written amendment executed by all parties hereto and approved by the appropriate officials in accordance with applicable Tennessee state laws and regulations.

**EXHIBITOR LIABILITY:** The Institution shall have no liability except as specifically provided in this Contract.

**GOVERNING LAW:** This contract shall be governed by and construed in accordance with the laws of the State of Tennessee. Lenders agree that they will be subject to the exclusive jurisdiction of the courts of Tennessee in actions that may arise under this Agreement. The Lenders acknowledge and agree that any rights or claims against the Exhibitor or its employees hereunder, and any remedies arising therefrom, shall be subject to and limited to those rights and remedies, if any, available under **Tennessee Code Annotated**, Sections 9-8-101 through 9-8-407.
